- **There is no PHR Law.**
- **Just laws that impact the development and use of PHRs.**
- **But, the Stimulus Package Changes That (a little bit . . .)**

Laws Impacting PHRs:

- Laws impacting PHRs are those impacting relationships in the health care system:
 - Consumer and the PHR.
 - Consumer and the sources of health information populating PHR.
 - Consumer and provider who has access to information in PHR.
- For each of these relationships, we are concerned with:
 - Ownership and Custody, Rights to Access and Disclose;
 - Privacy and Security; and
 - Liability.
